JOINT MEMBERSHIP INITIATIVE

Emerging biopharmaceutical companies and clinical/contract research organizations (CROs) play a critical role in the R&D ecosystem and share a common interest with larger established companies, i.e. IMC Full Members¹, in the development and commercialization of innovative medicines and vaccines.

In an effort to enhance networking opportunities and develop partnerships that will lead to the discovery of the next generation of life-saving therapies, qualifying LSO Core Life Sciences members that do not yet derive revenues from product sales and royalties in Canada are invited to join IMC through a joint membership initiative.

This initiative provides an exclusive opportunity for eligible new or existing LSO Core Life Sciences members to obtain membership within IMC as a Life Sciences Associate Member for a 20% premium on the LSO membership fee.

Life Sciences Associate Membership is open to Persons who do not qualify as Full Members, who support the purposes of the Association, and whose membership, in the determination of the IMC Board of Directors, would be consistent with the purposes of the Association and would enhance the ability of the Association to attain such purposes.

Under this joint initiative with LSO, membership in IMC will remain subject to the approval by the IMC Board of Directors.

As a LSO Core Life Sciences member, a company will have access to key benefits that include:

- Branding through LSO's communication channels such as our website, newsletter and the Ontario Life Sciences Asset Map – an interactive directory of life sciences organizations across the province;
- Member discounts to all LSO events (including monthly breakfast seminars, annual gala awards dinner, and various symposia);
- Access to LSO's volunteer committees that include initiatives around Policy and Government relations; Mentorship; Entrepreneurship; and Educational events;
- Access to LSO Member benefits programs that include discounts for flights, job postings, business services and laboratory supplies;
- Connectivity to the latest industry news and trends;
- Have a voice through Ontario's leading advocate for the Life Sciences Sector.

¹ IMC Full Member – An innovative company which researches, develops, manufactures and/or distributes pharmaceutical prescription preparations under its own label in Canada.
